SENIOR RESIDENTS: -

- Must be registered with the Central/State Medical Council.
- A postgraduate degree i.e., MD/MS/DNB as per MCI rule in the specialty concerned or its equivalent from a recognized University / Institute.

- Separate form to be filled and fees to be paid if applying for more than one post/department
- All original documents to be brought on the date of interview as mentioned in para 13 below and **no need to send the hard copy**

4. The above vacancies are provisional and subject to variation. The Director, AIIMS, Bathinda reserves the right to vary the vacancies including reserved vacancies as per the Govt. of India rules/circulars and requirements.

5. Reservation will be as per Government of India Policy.

6. Maximum Age-limit: -

Senior Resident: - **Not exceeding 45 (Forty-Five) years as on 13 Dec 2022.**

- Upper age limit shall be determined as on the date of publishing this notification in Institute website.
- No age relaxation would be available to SC/ST/OBC Candidates applying for unreserved vacancies.
- Age relaxation permissible to various categories is as under: -

Category	Age relaxation permissible beyond the upper age limited
SC/ST	05 years
OBC	03 years
For Persons with disabilities	10 years

Age relaxation will be regulated as per the DoPT instructions.

- To be eligible for selection for these posts, the candidate should pass the qualifying examination by 13 Dec 2022 & result should be declared to this effect on or before this date.**
- The candidates who are in service in any Government Institutions are required to submit No Objection Certificate from the employer at the time of Interview.

- (vi) Candidates applying under any of the reserved category posts, viz. SC/ST/OBC/OH will be considered subject to Caste/OH Certificate issued by the appropriate/ Competent Authority on the prescribed format. Community should be clearly and legibly mentioned in the Certificate. OBC candidate's eligibility will be based on the caste(s) borne in the Central List of Government of India. OBC candidate(s) should not belongs to Creamy Layer and their sub-caste should be match with the entries in Central List of OBC, failing which their candidatures will not be considered under any of the applied reserved category post(s).
- (vii) Only such persons would be eligible for reservation under OH quota in service/posts who suffer from not less than 40% of physical disability. Person who wants to avail the benefit of reservation would have to submit a Disability Certificate as issued by a Competent Authority in prescribed format. The candidates are to satisfy all eligibility criteria. They must possess the educational qualification and experiences as recognized by the Govt. of India. Their candidature will be cancelled at any stage if it is found that their educational qualification or experiences is not recognized by the Govt. of India.

9. **PAY SCALE**

Senior Resident: (Level – 11 of the Matrix (Pre-Revised PB – 3, entry pay of the ₹ 67,700/- Per Month + NPA + usual allowances admissible under rules) **NPA is applicable for Medical Candidates only.**

10. Reservation for Persons with Benchmark Disabilities Candidates (PwBD) is applicable by Govt. of India Policy, which will be provided on horizontal basis to PwBD candidate in their respective categories.

11. Criteria for Persons with Disabilities Candidates:

The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Govt. Hospitals / Institutions and countersigned by Medical Superintendent / CMO / Head of Hospital / Institution.

12. **SELECTION PROCEDURE:** The selection will be on the basis of the interview and if the number of candidates is more, written exam may be conducted for shortlisting for the interview or any other method found suitable by the competent authority.

13. **DOCUMENTS TO BE PRODUCED IN ORIGINAL AT THE TIME OF INTERVIEW:** On the day of walk-in-Interview, the candidate is required to be present 'in person' with filled application form (including application fee i.e., **Copy of Transaction receipt**) and all original certificates in **Recruitment Cell, Ground Floor, Admin Block, Medical College Building, AIIMS Bathinda before 9 AM** along with **one set of self-attested photocopies** at the time of Interview:

TERMS & CONDITIONS

- a) **Tenure**: - The appointment is for a period of 06 months and extendable upto 01 years upon the discretion of the competent authority. This appointment will not vest any right to claim by the candidate for permanent absorption in the institute or for continued appointment, which may be renewed or terminated as decided by the Institute.
- b) **Remuneration**: - The appointment will entitle the appointee to a remuneration as per pay-scale.
- c) **Leave**: - The leave entitlement of the appointee shall be governed by the Institute's leave rules as amended from time to time.
- d) The post of Senior Resident will be regulated as per the provision of Central Residency Scheme and governed by CCS (Temporary Service) Rules.
- e) The candidates are advised to see the institutional web site for any additional information and confirm about date and time / venue before coming. No personal / by post information will be sent.
- f) The Competent Authority reserves the right to change the number of vacancies, withdraw the process in full or in part and also the right to reject any or all applications received without assigning any reasons or giving notice etc.
- g) The period of experience wherever prescribed shall be counted after obtaining the prescribed qualification.
- h) The prescribed qualification is minimum requirement and mere possessing the same does not entitle any candidate for selection.
- i) This appointment is full time and private practice of any kind is prohibited. He/ She will have to work in shifts and can be posted at any place in the Institute.
- j) He/ She should also note that he/she will have to conform to the rules of discipline and conduct as applicable to the Institute employees.
- k) No travelling or other allowances will be paid to the candidate for joining the post. The candidate should not have been convicted by any Court of Law. Canvassing in any form will render the candidate disqualified for the post.
- l) If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have willfully suppressed any material information, he / she will be liable to be removed from services and such action as the appointing authority may deem fit.
- m) The decision of the Competent Authority regarding selection of the candidate will be final and no representations will be entertained in this regard. The decision of the committee shall be final and binding.
- n) All disputes will be subject to jurisdiction of Court of Law at Bathinda.
