- 9. The candidate who is already in government service shall submit 'No Objection Certificate' from the present employer at the time of Interview.
- 10. Canvassing of any kind will lead to disqualification.
- 11. The prescribed qualification is minimum and mere possessing the same does not entitle any candidate for selection.
- 12. Private practice of any type is prohibited.
- 13. The appointee shall not be granted any claim or right for regular appointment to any post of AIIMS.
- 14. He/She is expected to conform to the rules of conduct and discipline as applicable to the institute employees.
