**Note:**

1. As per guidelines EWS posts are not carried forward / or considered as backlog vacancy in case unfilled hence other category candidates may be allowed provisionally to apply for post subjected to condition that they will be considered for the post as an UR Candidate only if EWS category seat is otherwise not filled.

## **2. 4% reservation for PwD candidates on horizontal basis as per Government Rules.**

### **ESSENTIAL QUALIFICATIONS:**

#### **1. SENIOR RESIDENTS (Non-Academic):-**

- a) A medical qualification included in the first or second schedule or Part II of the third schedule to the Indian Medical Council Act 1956 (persons possessing qualifications included in the Part II of the third schedule should also fulfil the conditions specified in Section 13 (3) of the Act).
- b) Must be registered with the Central/State Medical Council.
- c) A postgraduate degree i.e. MD/MS/DNB in the specialty concerned or its equivalent.
- d) For the Department of Pathology, the essential qualification shall be MD pathology/MD Lab Medicine.
- e) For Cardiology essential qualification shall be DM Cardiology / MD General Medicine
- f) For Neurology, essential qualification shall be DM Neurology / MD General Medicine
- g) For Cardiothoracic & Vascular Surgery (CTVS), essential qualification shall be MCh CTVS / MS General Surgery
- h) For Neurosurgery, essential qualification shall be MCh Neurosurgery / MS General Surgery
- i) For Urology, essential qualification shall be MCh Urology / MS General Surgery

#### **AGE LIMIT: Senior Resident**

Age limit for post of SR is 45 years (relaxable by 5 years for SC/ST candidates and 3 years for OBC candidates).

In case of Physical Handicapped (OPH) candidates, age relaxation up to a maximum period of ten (10) years for General Category, Thirteen (13) years for OBC category and fifteen (15) years for SC/ST category candidates.

#### **PAY SCALES: Senior Resident**

In Pay Matrix (Level-11) with a minimum of Rs.67,700/- + NPA (for medical personnel) as per recommendations of the 7th CPC.

## **2. APPLICATION FEES:**

For General/OBC/EWS: Rs. 1,000/- ,  
For SC/ST category: Rs. 800/-,  
For PWBD category application fee is exempted.

Application fee is required to be remitted through online payment gateway available in the website i.e. [www.aiimsrbl.edu.in](http://www.aiimsrbl.edu.in) The Application fee is non-refundable. Online applications without fee shall be summarily rejected.

### **3. PROCESS OF SELECTION:**

The selection of Senior Residents will be done through-

- a) Written Examination (MCQ based)- 80% weightage
- b) Departmental assessment-20% weightage

### **4. DOCUMENTS TO BE PRODUCED IN ORIGINAL AT THE TIME OF DOCUMENT VERIFICATION:-**

The Candidate should bring following original documents and one set of self-attested photocopies at the time of document verification in case of his/her selection:-

1. Identity Proof (PAN Card, Passport, Driving License, Voter Card, Aadhar Card etc.)
2. Address Proof.
3. Certificate showing Date of Birth. (Birth Certificate/ 10th Certificate). No Age relaxation would be available to SC/ST/OBC candidates applying for unreserved vacancies.
4. Photocopies of PAN Card and Bank Passbook and four recent passport size photographs (At the time of Joining for only selected candidates)
5. Class 10th & 12th Marksheet and Certificates.
6. Qualifying degree
  - a. MBBS Marksheet and degree certificates.
  - b. MD/DNB/MS or equivalent degree certificate.
7. Attempt and Internship Completion Certificate.
8. Registration with Medical Council of India /State Medical Council & DCI for Dentistry candidates.
9. Experience Certificate (if any).
10. FMGE certificate conducted by NBE (For foreign graduate).
11. Reservation category Certificate (OBC\*/SC/ST/PH) (\*Candidate should belong to non-creamy layer of Central List of OBC in Government of India format).
12. In case of OBC & EWS candidate, the OBC& EWS certificate must be issued within one year (Older certificate not be entertained).
14. Candidates working in Government Institution are required to submit “No Objection Certificate” from their present employer.

**Candidates who do not produce the above mentioned original documents at the time of documents verification shall not be offered appointment even though if he/she is selected on the basis of examination and Departmental assessment.**

## **General Conditions**

The applicants applying in response to this advertisement should satisfy themselves regarding their eligibility for the aforesaid post and must fulfill all the eligibility criteria on or before the last date of submission of form i.e. 07<sup>th</sup> April 2023 failing which their application will be rejected.
3. The duly filled on-line application form with all requisite documents and proof for deposit of fee must be submitted before the last date through online form submission link only. There is no need to send hard copy to the Institute. However, the documents mentioned at point no.4 on pre-page must be uploaded with the application form and original set along with one self-attested phone copies of each document must be brought at the time of document verification.

1. The appointment is initially for a period of One (01) year, which may extendable up to three (03) years based on performance & conduct.
2. The leave entitlement of the appointee shall be as per the Central Residency Scheme and Institute Policy.
3. The appointee shall perform the duties as assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra/additional remuneration will be admissible in case of such assignment.
