- (i) A Master's degree with 55% marks (on an equivalent grade in a point scale wherever grading system is followed) in concerned/relevant/allied subject from an Indian University Or an equivalent degree from an accredited foreign University.
- (ii) Besides fulfilling the above qualifications, the candidates must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph.D. Degree in accordance with the University Grants commission (Minimum Standards and Procedure for Award of M.Phil/Ph.D. Degree) Regulation, 2009 or 2016 and their amendments from time to time, as the case may be, are exempted from NET/SLET/SET

The candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/By laws/Regulations of the Institution awarding the degrees and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in the University subject to fulfillment of the conditions:-

- a) The Ph.D. degree of the candidate has been awarded in regular mode;
- b) The Ph.D. thesis has been evaluated by at least two external examiners;
- c) An Open Ph.D. Viva-Voce of the candidate should has been conducted.

d) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a referred journal;

e) The candidate has presented at least two papers based on his/her Ph.D. work in Conference/Seminars, sponsored/funded/supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfillment of above conditions should have been certified by the Registrar/Controller of Examinations of the University.

The Ph.D. degree should has been obtained from a foreign University/Institution with a ranking among top 500 in the World University Ranking (at any time) by any one of the following:

- (i) Quacquarelli Symonds (QS), (ii) The Times Higher Education (THE), or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghali Jiao Tong University (Shanghai).
