
Walk in Interview for Guest Faculty in Department of Hotel Management and Hospitality

Eligible and interested candidates are invited for Walk-in-Interview in the Department of Hotel Management and Hospitality (UTD) on 16th September, 2022 at 11:00 AM for the appointment of Guest faculty on purely temporary and per period basis with an application on plain paper giving their brief bio data and self-attested copies of mark sheets/certificates/Degree of academic qualification, research and experience along with original on the date of walk-in-interview. Department of Hotel Management and Hospitality	06 HMCT 04 (Food production, Accommodation, F&B Service, Bakery) Management. 02 (Financial Management, Tourism Management, Marketing)	(A) As per UGC norms Good academics record with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University, or an equivalent degree from an accredited foreign university. Besides fulfilling the above qualification, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC CSIR, or similar test accredited by the UGC like SLET/SET. Notwithstanding anything contained above in (i) and (ii), candidates, who are, or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009 or as amended from time to time shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Guest Faculty. OR (B) As per AICTE Norms Minimum 4 years Bachelor's Degree in HMCT and Master's Degree in HMCT or in relevant disciplines with First Class or equivalent in any one of the two degrees. OR Minimum 4 years Bachelor's Degree in HMCT with First Class or equivalent and minimum of 5 years of relevant experience at a managerial level not less than Assistant Manager in a 4 - star Hotel or in a similar position in the hospitality industry/ tourism industry. The candidates / incumbents having qualification of three years Bachelor degree in HMCT along with the other qualifications and experience as mentioned in the AICTE Gazette Notification dated 1st March 2019 are eligible for the purpose of recruitment and promotion under CAS provided that the candidate has confirmed admission in 3 years Bachelor's programme in HMCT before publication of AICTE notification dated 1st March 2019 and produce an evidence of this admission. However, in all other cases qualifications published in AICTE Gazette dated 1st March 2019 shall be referred.

Important information:

1. Selected candidate will get ₹300 per class up to four classes per day or ₹ 31200/Month whichever is less.
2. Selection is only for the current academic session or till the regular appointment of the permanent faculty in the department.
