I. VAVCANCIES AND EDUCATIONAL QAULIFICATIONS:

1. Applications are invited from the eligible candidates for the post of Assistant Professors in the Government medical colleges and Teaching Hospitals under Directorate of Medical Education through direct entry and Lateral entry methods
2. Recruitment is on regular basis.
3. Recruitment on shall be as per the service rules issued in the GO Ms No 154 HM&FW Dt 27.06.2002 read with the amendment issued from time to time and Teachers Eligibility Qualifications in Medical Institutions Regulations issued by NMC from time to Time
4. **Total Number of Vacancies : 631.** These vacancies are tentative and may increase or decrease.
5. Details of specialty wise vacancies is at **ANNEXURE 1** to the notification. Vacancies include 278 existing and 353 arising due to promotions during panel year 2022-23. No of arising vacancies are subject actual promotional posts filled.
6. **EDUCATION QUALIFICATION (BOTH DR & LE):**

4	Assistant Professor of Physiology	MD/MS Physiology from the college recognized by MCI/NMC. In case of non-availability of candidates with above qualification candidates with following qualification will be considered: M. Sc (Medical Physiology) on regular mode with PhD in Medical Physiology on Regular Mode.

7. Pay Scale: Salary will be paid as per the rules in force till the completion of probation period. The 7th UGC Pay scales (G.O.Ms.No.22, HM & FW (A1) Dept., Dated 01.03.2021) will be applicable after completion of the probation period.

II.FOR THE CANDIDATES APPLYING UNDER DIRECT RECRUITEMENT:

1. For the candidates applying under Direct Recruitment mode shall have completed the one year of Senior Residency after completion of Required qualification. SR is not required in case of super specialties and Dental specialties. Candidates who have completed DNB in institute not recognised by NMC shall have completed additional one year period of SR
2. **AGE:**
 - i. OC candidate should not have completed 42 years as on date of Notification (should not have been born before 01-12-1980).
 - ii. EWS/SC/ST/BC candidates should not have completed 47 years as on date of Notification (should not have been born before (01-12-1975)
 - iii. Physically Handicapped persons should not have completed 52 years as on date of Notification (should not have been born before (01-12-1970)
 - iv. Ex-servicemen should not have completed 50 years as on date of Notification (should not have born before (01-12-1972)
3. Rule of Reservation will apply as per A.P State and Subordinate service Rules in force and also as per GO Ms No 857 HM&FW Department Dt 14.11.2022 and GO Ms No 858 HM&FW Department Dt 14.11.2022. Details of Roster Matrix is at **Annexure - VI**
4. ONLY LOCAL candidates are ELIGIBLE to apply for the direct recruitment. NON-LOCAL candidates are NOT ELIGIBLE to apply.
5. **LOCAL CANDIDATURE:**
 - i. Candidates who are Local to Andhra Pradesh ONLY need to apply. (Candidates who studied from 4th Class to 10th Class in the State of A.P.

and candidates who migrated to any part of AP from the State of Telangana within a period of 3 years from 2nd June 2014. (As per G.O. No. 132 GAD Dt. 13-6-2016 & G.O.Ms.No. 133 GAD Dt. 13.06.2016) are considered as Local).

- ii. The Residence Certificate/ Nativity/ Domicile Certificate issued by MRO/ Tahasildar will not be allowed for Local consideration without mentioning the G.O. No. 132 GAD Dt.13-6-2016 & G.O.Ms.No.133GAD Dt. 13.06.2016 for the candidate who studied in the state of Telangana before bifurcation.
- iii. The Residence Certificate will not be accepted if a Candidate has studied in any Educational Institutions up to SSC or equivalent Examination, such candidates have to produce study certificates invariably.

6. In service candidates applying under DR:

- a. Candidate who is in State Government service and desires to apply in Direct Recruitment shall have to obtain NOC from DPHFW /Commissioner/DME/ respective competent authority. Candidate shall submit the format in the prescribed format at ANNEXURE II
- b. Such candidates, if selected, will have to submit an ‘accepted resignation letter’ from the DPHFW/Commissioner /DME and only then, will they be permitted to join as Assistant Professor.
- c. Candidates working as Assistant Professors under DME are NOT eligible to apply For SAME SPECIALITY they are working in.

7. SELECTION PROCEDURE FOR DR:

- A. Selection will be based on merit and rule of reservation
- B. Merit list will be prepared for all the candidates who applied online and fulfilled all the eligibility conditions. Selection lists will be prepared based on merit lists and roster points as per the Rules of Reservation issued in AP State and Subordinate Services.
- C. Total Marks –100
- D. 75 Marks based on the marks / grade obtained in the qualifying degree. Those who are not having PG marks memo or Grade, percentage of marks will be taken as 50% (50% x 75=37.50)
 - a. It is the responsibility of the candidate to obtain and submit marks memos from the competent authorities where ever grades instead of marks are issued.
 - b. Regarding the Grades: (Marks will be considered as75%) (As per Govt Memo No. 4296/A1/2015, Dated 22.04.2015)

- E. 10 marks based on weightage for number of years since passing qualifying examination is up to 10 marks @ 1 mark per PG /Completion of PG / Super-specialty completed year.
- F. 5 marks of weightage will be provided to the candidates who have completed PG/Super Specialty from Central Institutions.
- G. 15 Marks to the contract service rendered in Government institutions
- H. Contract service can be calculated from the date of completion of Post-Graduation (Requisite qualification) only.
- A. 2.5 marks per six months in Tribal Area.
- B. 2 marks per six months in Rural Area.
- C. 1 mark per six months in Urban Area
- I. Contract Service Certificate issued by the competent authority and signed by the Superintendent of Government Teaching Hospital /DM & HO / DCHS shall be submitted for claiming the contract weightage. Contract weightage will not be awarded, in case of non-submission of signed certificate from the above authorities.
- J. Contract weightage, if already utilized in any recruitment of state government, will not be awarded again. Candidates shall submit the declaration to that effect in the format at **Annexure No. III**. Non submission of declaration leads to non-entitlement of contract weightage
- K. Weightage will be awarded up to 15 Marks for the candidates who rendered their services on contract basis for COVID-19 duties.
- a. Contract service will be reckoned up to the date of notification as per Government Memo no.4274/D1/2013, HM&FW(D1) Dept., dt.10.07.2014.
- b. Spells of services will also be considered for weightage marks.
- c. Contract weightage will be awarded as per G.O.Rt. No. 211, HM & FW (B2) Dept., Dated 08.05.2021 and G.O.Rt.No.7 HM&FW(B2) Department Dt.06.01.2022 read with circular no.03/CHFW/2022, dated 11.02.2022 of CHFW
- d. Following documents to be submitted to claim COVID-19 weightage:
1. Appointment order for COVID-19 management.
 2. Monthly attendance certificates.
 3. Bank statement indicating payment of monthly remuneration along

with COVID-19 weightage service certificate.

4. Service certificate from the competent authority in the prescribed proforma (DMHO/DCHS/Medical Superintendent in case of GGH).
5. Covid contract weightage will not be awarded in case of non-submission of any of the above certificates from **d(1) to d(4)**.

III. FOR THE CANDIDATES APPLYING UNDER LATERAL ENTRY

1. Eligibility Criteria

- a. Civil Assistant Surgeons working in Directorate of Public Health & Family Welfare or Andhra Pradesh Vaidya Vidhana Parishad are only eligible to apply.
 - b. Assistant professors working in Directorate of Medical Education are eligible to apply for the Assistant Professors in super specialties only.
 - c. Candidate shall be an approved probationer or should have completed the probation period in the cadre of CAS/ Assistant Professor.
 - d. There shall not be any disciplinary charges pending against the candidate and shall not be in unauthorized absence.
2. Rule of Reservation applicable to the promotions is adhered to, in the recruitment through lateral entry.
 3. Candidate applying for Lateral Entry shall submit NoC from the HoD in the prescribed format at **ANNEXURE IV**
 4. **Selection Procedure for LE:**
 - a. Merit list will be prepared based on the rank given by the respective appointing authority at the time of recruitment as CAS / Assistant professor.
 - b. Selection list will be prepared based on merit and the rule of reservation applicable to the promotions as per AP state and subordinate service rules.
 5. The decision of the selection committee as per G.O. Ms. No. 109, HM & FW (A2) Dept., Dt. 23.6.2014, Govt., Memo No.4298/A1/2015 HM & FW (A2) Dept dated 22-04-2015 and G.O. Ms. No. 154, HM & FW (A1) Dept., Dt. 4.5.2002 in all aspects and all respects pertaining to application and its acceptance or rejection as the case maybe, the selection or otherwise of any candidate shall be final in all respects and binding on all concerned.

IV. HOW TO APPLY (For Both Lateral Entry and Direct Recruitment):

1. Applications shall be submitted online at dme.ap.nic.in from 01.12.2022 to 7.12.2022 11.59PM
2. The candidates shall have to pay the application fee Rs.1000/- for OC and Rs.500/- for BC, SC, EWS, ST and PH candidates.
3. Payment shall be done in Online Mode only.
4. Interested candidates are requested visit website dem.ap.nic.in. Candidates shall submit the application online and uploading following certificates in support of their claims in the application

 - b. SSC Certificates (proof of date of birth)*
 - c. Intermediate certificate*

 - f. PG degree marks memo/Super-Specialty degree marks memo*
 - g. AP Medical Council Registration Certificate*
 - h. Senior Residency (SR) Completion certificate* (Not required for super specialties, Dental specialties and candidates applying under LE)
 - i. Study Certificate from 4th to 10th Class. In case of study of 4th to 10th in Telangana and migrated to AP after bifurcation, then certificate from the revenue authorities to that effect as per G.O.Ms.No.132 & 133 GA (SPF&MC) Dept.13.06.2016 * (proof of local candidate)(Not applicable for candidates applying under LE)
 - j. In case of candidates who are presently employed with state or central Government and applying under DR, NOC from the appointing authority in the format at Annexure III*
 - k. In case of service candidates applying under LE, NOC from the appointing authority in the format at Annexure IV*
 - l. Declaration given in **Annexure No. V** must be uploaded by the candidate duly filled and signed*.
 - m. Contract Service Certificate from DMHO/DCHS/ Medical Superintendent /Principal (for the period after completion of PG degree), Contract service will not be given without proper service certificate from the DMHO/DCHS /Medical Superintendent/Principal, given in **Annexure No. II**. (Not applicable for candidates applying under LE)
 - n. If a person belongs to Ex-serviceman category, certificate regarding the same has to be enclosed. (Not applicable for candidates applying under LE)
 - o. Candidates who claim for VH/MH/HH/OH vacancy, must submit Disability Certificate to that extent, issued by concerned medical board or SADAREM.

- p. Caste Certificate in case of SC/ST/BC or Social Status (for candidates claiming EWS) Certificate issued by Competent authority. If caste certificate is NOT submitted, then such candidate is considered as OC.
 - q. Certificate with * Marks shall be mandatory upload online along with the application. Without which the application will be rejected. No certificate or paper will be accepted after submission of online application.
- 6.** No application/certificate will be accepted in any mode other than ONLINE.
