- Application Fee (For All Posts) Rs. 250/- (Rupees two hundred and fifty only) for General & OBC Candidates and Rs. 50/- (Rupees Fifty only) for SC/ST candidates by way of Demand Draft drawn in favour of ESI Saving Fund Account No.2 payable at Kollam.
- 2. PWD/Female applicants are exempted from Application Fee.
- 3. Those who belong to SC/ ST/ OBC category should produce valid caste certificate issued by the Tahasildar / Revenue Divisional Officer. OBC certificate should be in the prescribed form as per Government of India instructions which should certify that the candidates do not belong to Creamy layers.
- 4. The selection will be based on qualification, experience & interview. Eligible candidates will be informed the date and time of interview in due course through e-mail/mobile and the interview will be conducted at ESIC Model and Super Speciality Hospital, Asramam, Kollam.
