RECRUITMENT OF TUTOR

Employees' State Insurance Corporation is a statutory body constituted under an Act of Parliament (ESI Act, 1948) and works under the administrative control of Ministry of Labour and Employment, Government of India. Employees' State Insurance Corporation proposes to recruit teaching faculty i.e. Tutor in ESIC Dental College & Hospital, Sector-15, Rohini, Delhi-89 on contract basis for one year. Mode of Selection:-

The selection for the above post will be on the basis of interview conducted by the Selection Board at ESIC Dental College & Hospital, Sector-15, Rohini, Delhi-89. However, ESIC reserves the right to change the centre, if need be.

Shortlisting Criteria:-

Candidates would be shortlisted based on their BDS performance (combined scoring of all the professional exams) in order of merit. In case of same merit position, candidates with higher age (within the prescribed age eligibility criteria) will rank higher than a younger candidate.

Note:

- A. In case of same marks and same age of the candidate, candidates with higher marks obtained in BDS Final year shall be given preference for short-listing.
- B. If the numbers of eligible candidates exceed the desired ratio of 1:5 even after applying all criteria as above, all such candidates will be called for the interview.
- C. The post of Tutor is not department specific and will be rotated amongst all the departments of Dental College, including casualty postings and night duties.
- D. Since the total permissible tenure for the post of Tutor/ SR / Lecturer / Demonstrator is 3 years, and the present post is for one (1) year, candidates who have already worked as Tutor / SR / Lecturer / Demonstrator in any Govt. hospital/ Institute for more than 2 years need not apply. Any such candidate will not be considered eligible for the present post.
