1. All the interested candidates are requested to appear for document verification within the scheduled time (08.30AM - 10.30 AM) by following Covid appropriate behavior like wearing face mask and carrying sanitizer and maintaining social distance etc. No candidate will be allowed to attend document verification after 10.30 AM on the scheduled date.
2. Only the Candidates, whose documents are verified and found eligible for the post of Senior Resident (1 year under consolidated remuneration) will be allowed to attend walk-in interview.
3. Reservation of posts is applicable as per Government of India Guidelines.
4. One post in Senior Resident (1 year under consolidated remuneration) is horizontally reserved for PwD category in identified posts.
5. Only when there is no person with benchmark disability available for the post, the employer shall fill up the vacancy by appointment of a person, other than a person with benchmark disability, vide DoPT office memorandum dated 15.01.2018. The person who suffers from not less than 40% of disability will only be eligible for the benefit of reservation and other relaxations under PWD category as permissible under the rule. The applicant must have a valid Disability Certificate issued from the competent authority. i.e, Medical Board duly constituted by the Central or State Government. Certificate issued by the Medical Practitioner, Hospital or any other Institution will not be considered. The Physical disability of finally selected candidates would be ascertained by a Medical Board of the Institute specifically constituted for this purpose, if deemed necessary.
6. The Dean, ESIC Medical College & Hospital reserves the right to vary these vacancies including increase or decrease or cancellation of filling up of any or all post without assigning any reason.
7. Change in date of interview, etc. if any, will be intimated on website only. Candidates are advised to check the website regularly for any updated information relating to the recruitment. Other terms and conditions as mentioned in Annexure “A”.

**ELIGIBILITY CRITERIA FOR THE POST OF SENIOR RESIDENT
(1 YEAR TENURE UNDER CONSOLIDATED REMUNERATION)**

Upper age limits will be 45* years as on 23/08/2022.

- (i) MBBS and MD/MS/DNB Degree from MCI/NMC recognized Medical College / Institution.
- (ii) Qualification and Experience as per "Teachers Eligibility Qualifications in Medical Institutions, 2022" as amended and applicable as on date to the respective posts.
- (iii) Should have registered with MCI/NMC or State Medical Council.

*Relaxation for SC/ST/OBC/PH/Ex-SM candidates will be applicable as per Government Rules.

Emoluments for The Post of Senior Resident (1 year tenure under consolidated remuneration)

1. For Senior Resident (1 year tenure under consolidated remuneration) - Rs. 1,30,797/- (Consolidated remuneration) per month. In addition to the pay above, the Senior Resident will be entitled for transport allowance with DA on transport allowance as per rules. DA on transport allowance will be revised from time to time as per rules.

The consolidated remuneration will be revised whenever there is revision of rates of DA as per ESIC Hqrs. Office Memorandum no. Z-17/11/1/2007/Med.IV (Pt.file) dated 13.04.2022.

General Terms & Conditions for Senior Resident (1 year tenure under consolidated remuneration)

- a) The appointment / engagement will be for a period of **one year** or till regular incumbent joins, whichever is earlier under consolidated remuneration.
- b) The Senior Resident (1 year tenure under consolidated remuneration) is entitled for leave as per the Contractual Labour [Regulation & Abolition Act] 1970.
- c) Private practice of any kind will not be allowed.
- d) Rules for Reservation will be implemented as per Govt. of India instructions.
- e) The Appointment shall not confer any right or preference for regular appointment.
- f) No claim for any service benefits like PF, Pension, Gratuity, Medical allowances, Medical benefits, Seniority, Promotion etc. will be admissible.
- g) Candidate must be registered with State Medical Council/Medical Council of India/ NMC as applicable, before joining the post.
- h) Candidate in the Government Service should submit "No Objection Certificate" from the employer at the time of Interview and Relieving order at the time of joining.
- i) No TA/DA will be admissible for interview or joining.
- j) ESI Corporation may increase or decrease or cancel filling up of any or all posts without assigning any reason at the discretion of the Appointing Authority.
- k) Candidates applying in OBC/SC/ST/EWS/PWD Category must possess the certificate issued by competent authority, valid for admission/ job in Central Govt. Institutions issued before the date of interview, failing which he/she shall not be allowed to appear in interview for the reserved category. However, he/she can be treated as UR Candidate.

- l) The candidates claiming reservation/age relaxation on grounds of belonging to OBC [non-creamy layer] should submit the community certificate in Annexure “A” prescribed vide Govt. of India, Department of Personnel and Training O.M No. 36036/2/2013-Estt (Res) dated 30.05.2014 failing which the benefits of reservation /relaxation will not be given and their application shall be rejected and no request /correspondence will be entertained. Certificate issued in other formats will not be accepted and the candidature will be treated as “General Category” for all purposes.
- m) The candidates appointed under PWD quota will be adjusted against the vacancy of respective categories of SC/ST/OBC and UR quota. The disability certificate should be issued by a duly constituted and authorized Medical Board of the State or Central Government Hospitals/Institutions.
- n) The DEAN has the discretion to increase/decrease the number of vacancies depending on actual requirement or to cancel this recruitment or to withdraw offer of appointment.
- o) The Senior Resident (1 year tenure under consolidated remuneration) so selected will be required to submit acceptance/consent letter in writing before appearing for medical examination.
- p) The doctors at any time found guilty of any gross misconduct or negligence of his/her duties shall be terminated without any notice or payment in lieu of the notice period.
- q) The absence from work for a period of fifteen days without proper permission of the competent authority will amount to voluntary abandonment of engagement and automatic termination. The Senior Resident are required to mark attendance manually as well as in Aadhar Based Bio-metric Attendance System (BAS) daily during scheduled working days.
- r) **They will also be required to attend emergency, floor duty and other clinical duty as assigned by the Competent Authority or his/her subordinate authority authorized.**
- s) **They will also be required to perform their duties in other departments as assigned by the competent authority.**
- t) Selected candidates will have to join duty immediately or the date indicated in the offer of appointment/engagement likely to be issued.
- u) The Senior Residents so engaged will be required to enter into a contractual agreement for the purpose on a stamp paper of Rs.100/-.
- v) The Selected Senior Resident candidates have to deposit security amount of Rs.15,000/- (Rupees Fifteen Thousand) in favour of ESI Fund A/C No. 1 payable at State Bank of India, Ashok Nagar, Chennai-78 and produce the demand draft at the time of joining. However, this amount will be appropriated towards administrative cost in case, the candidate resigns/terminates his/her contract before completion of his/her tenure. The contract is liable to be terminated at any time without assigning any reason thereof after giving one month’s notice on either side or on payment of one month’s emoluments in lieu of thereof.

- w) **Interview fee of Rs.500/- in favour of ESI Fund A/c No.1 payable at Chennai (By Demand Draft) for all except candidates belongs to SC/ST/WOMEN/PWD Category.**
- x) Candidate is permitted to apply for only one post at a time.
- y) EWS candidate appearing for the post must have EWS certificate as per Govt. prescribed format and valid on the date of interview.
- z) On selection candidates has to open an SB Account in the State Bank of Indian (Any branches) [This is applicable to cases where SB account is not held in State Bank of India].
