General Instructions to the applicants:

1. Applicants are advised to ensure that they possess the minimum essential qualification and experience laid down for the post before appearing for Selection Process. Qualification obtained has to be from a recognized University/Institute. Eligibility in terms of age, qualification, and experience of a candidate shall be considered as on the last date for receipt of application.
2. Selected candidates shall not have a claim on any regular position. They shall not be bestowed any of the privileges like Housing, Medical Facility and Other benefits available to regular employees of the Institute.
3. **No TA/DA will be paid for attending the Interview.**
