General Instructions to the applicants:

1. Applicants are advised to ensure that they possess the minimum essential qualification and experience laid down for the post before appearing for Selection Process. Qualification obtained has to be from a recognized University/Institute. Eligibility in terms of age, qualification, and experience of a candidate shall be considered as on the last date for receipt of application.
2. Selected candidates shall not have a claim on any regular position. They shall not be bestowed any of the privileges like Housing, Medical Facility and Other benefits available to regular employees of the Institute.
3. **No TA/DA will be paid for attending the Interview.**
4. In case of any inadvertent mistake in the process of selection, which may be detected at any stage even after issue of the appointment letter, the Institute reserves the right to modify, withdraw or cancel any communication made to the Applicants.
