**INSTRUCTIONS:**

**1. TENURE OF THE POSITIONS:**

- a) All the above positions are purely on temporary basis and co-terminus with the project or up to 30/09/2023 whichever comes earlier and without any provision for regularization.
- b) The Director, NARL reserves the right to cancel/postpone the interview without any reason thereof. He also reserves the right to terminate the service, even before completion of the project for which no appeal thereof shall be made.

- 2. AGE LIMIT :** Maximum age shall be as prescribed as on date of Interview. Age relaxation as per Government of India orders are applicable to SC, ST, OBC, Ex-Servicemen, Persons with Disabilities (PWD). Candidate claiming age relaxation have to submit valid documentary proof.

### 3. SELECTION PROCESS :

- a) Interested and eligible candidates are required to directly come to the venue alongwith the **Application (as per prescribed format) & Biodata/ CV** and all relevant original documents in proof of details furnished in the **Application** alongwith a set of self-attested photocopies of the documents and for walk-in interview on the scheduled date and time.
- b) The walk-in interview of eligible candidates will be conducted by the selection committee.
- c) The candidate will be selected on the basis of qualification, relevant experience and interview performance.
- d) The decision of NARL in all matters relating to eligibility, acceptance or rejection of candidates, mode of selection, conduct of interview, will be final and binding on the candidates and no enquiry or correspondence will be entertained in this connection from any individual or agency on behalf of the candidate.
- e) Candidates who are already employed under Central/State Government, Public Sector Undertakings or Autonomous Bodies will also have to produce the "No Objection Certificate", in original, at the time of interview. In case the candidate fails to produce any of the above documents or if any information furnished in the Biodata is found to be wrong or false, the candidate will not be interviewed. - f) **It is the absolute responsibility of the candidate to ensure that he/she fulfills the eligibility criteria as notified in the advertisement.**

### 4. Other conditions/instructions :

- a) Only passed candidates are eligible to apply. Students awaiting for final result need not to apply.
- b) The appointment will not confer any claim or right for regular appointment in any of ISRO/DOS Centers.
- c) Original education, experience, Caste/Tribe, identity certificate shall be produced at the time of interview otherwise the candidature of the candidate will be cancelled.
- d) The selected candidate will work on specific research theme (project). Selected candidates should be willing to work anywhere in India (including remote places) and take part in field campaigns/experiments as per requirements.
- e) Candidates belonging to OBC must submit a certificate- specifically including the clause regarding exclusion from creamy layer which should be updated/valid at the time of interview.
- f) Mere fulfillment of the qualitative requirements of the posts will not entail a candidate to be selected.
- g) NARL/DOS reserves the right not to fill up all or any of the position, if so decides.
- h) Any information furnished in the application is found to be false or wrong, the candidate will not be interviewed.
- i) TA/DA will not be paid to any candidate for appearing in this interview.
