**Remuneration:** Rs. 1000/- per class for both UG and PG subjects subject to a maximum of Rs. 40,000/- per month.

**Desirable Qualification:**

2. Ph.D. in relevant subjects.

**The candidates will also be given due weightage for publication in reputed journals as well as for experience in related fields.**

The engagement will be for the academic year 2022-23. The tenure of engagement may be terminated at any time before the end of academic year and also it may be further extended on satisfactory performance with due approval from competent authority. The incumbent shall not have any claim for regular appointment under OUAT.

The guest faculty may leave the assignment, on their own volition, by giving one-month notice and he/she will be relieved on acceptance of resignation, else he/she has to deposit one-month remuneration wherever applicable.

The candidate must bring all the original certificates from HSCE onwards and experience certificate (if any) with them, without which the candidate will not be allowed for the interview.

No objection certificate from the present employer, if any, is to be produced at the time of interview.

The selection panel will remain valid for one year. The undersigned reserves the right to increase or decrease the number of positions depending upon the need and approval of competent authority or to cancel the interview without assigning any reason.

In the event, suitable candidates are not available as per the eligibility criteria mentioned above, candidates having Master's Degree in relevant/ allied subject may also be considered.

Interested candidates will have to appear for a **walk in interview on 16<sup>th</sup> Nov, 2022** in the Office of the Dean, CAET, OUAT, Bhubaneswar.
