The candidates who fulfill the following eligibility criteria are requested to attend the same along with their original certificates/testimonials and one set of Bio-data, photocopy of certificates and latest coloured photograph. No separate interview letter will be sent and no TA/DA will be given for attending the interview.

Essential Qualifications/Eligibility:

- a) **A medical qualification included in the first or second schedule or part-II of the third schedule to the Indian Medical Council Act, 1956 (person possessing qualifications included in the part-II of the third schedule should also fulfill the conditions specified in Section 13 (3) of the Act.)**
- b) **Must be registered with the Central/State Medical Council.**
- c) **A postgraduate qualification of an Indian University or MD (Pathology) or its equivalent degree recognized as such by the Medical Council of India.**

Age limit	45 years (relaxable by 5 years for SC/ST candidates, 3 years for OBC candidate).

The age relaxation for persons with disability would be 10 years (additional 5 years for SC/ST and 3 years for OBC candidates).



The candidates who have completed 3 years tenure of Senior Residency and have done DM/M.ch are not eligible.
