

TERMS & CONDITIONS

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. 2. **Tenure:** The assignments are purely on contract basis for a period upto 31st March 2023 **further extension is subjected to the sanction from the funding agency** These appointments will be made from the staff strength sanctioned to Regional VRDL but **under DHR pattern** and the appointments will not vest any right to claim by the candidate for regular appointment or permanent absorption in PGIMER/DHR/ICMR or continued contractual appointment.
3. **Expiry of Contract:** The contract will automatically expire on completion upto 31st March 2023 **further extension is subjected to the sanction from the funding agency** or earlier in case of withdrawal of support by funding agency. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
4. **Leave:** The leave entitlement of the appointee shall be governed in terms of the DHR/ICMR leave policy as amended from time to time.


