**Eligibility & other service conditions for the appointment of Past Champion Athlete as Coaches**

A. (i) **Eligibility Criteria for Individual Sports**

1st preference	Represented India at recognized international competition under recognized NSF/Association of respective sport.
2 <sup>nd</sup> preference	Medal winner at Senior National Past championship conducted by recognized NSF OR Medal winner at Khelo India Games
3 <sup>rd</sup> preference	Medal Winner at National AIU past championship.
4 <sup>th</sup> preference	Represented State in Senior National Past championship conducted by recognized NSF OR Participation in Khelo India Games.

(ii) **Eligibility criteria for Team Sports**

1st preference	Represented India at recognized international competition under recognized NSF/Association of respective sport.
2 <sup>nd</sup> preference	Part of medal winning team at Senior National past championship conducted by recognized NSF OR Part of medal winning team at Khelo India Games.
3 <sup>rd</sup> preference	Part of medal winning team at National AIU past championship.
4 <sup>th</sup> preference	Represented State in Senior National past championship conducted by recognized NSF OR Participation in Khelo India Games

- B. **Age Limit:** Maximum age limit for applicants will be 40 years. However, relaxation may be accorded in deserving cases.
- C. **Tenure:** The contractual engagement will be initially for a period of 02 (two) years which could be further extended on the basis of performance.
- D. **Remuneration:** Fixed monthly remuneration of Rs.25,000/- i.e. Rs. 3.00 lakh per annum.
- E. **Eligibility Documents:** The eligible and interested candidates may report with their original educational, professional, sports achievement certificates, ID proof and Aadhar Card in the office of Director, 1<sup>st</sup> Floor in the Directorate of Sports, Panjab University, Chandigarh.

- F. **Tax Deduction at Source:** The Income Tax or any other tax liable to be deducted, as per the prevailing rules will be deducted at source before effecting the payment, for which the Panjab University will issue TDS/Service Tax Certificates, as applicable.
- G. **Other Allowances:** No TA/DA shall be admissible for interview and joining the assignment or on its completion. No other facilities like DA, accommodation, residential phone, conveyance/ transport, personal staff, medical reimbursement, HRA and LTC etc. would be admissible.
- H. **Extension:** Performance of the selected candidates would be continuously reviewed and their extension will be considered on the basis of periodic review/requirement.
- I. **Other Conditions:**
- i) This appointment will be on contract basis and does not confer any right to claim to permanent employment in Panjab University, Chandigarh.
  - ii) In case of performance is not found satisfactory the competent authority reserves the right to terminate the contract by giving 30 (thirty) days' notice to the past Champion Athlete and Panjab University also may withdraw offer at any time without assigning any reason.
