#### Context

The Tata Institute of Social Sciences (TISS) is a Deemed to be a University under Section 3 of the University Grants Commission Act (UGC), 1956, and has been engaged cutting edge research, teaching and community engagements.

The Post-Doctoral Fellow will be part of an international research team led Professor Abdul Shaban, as research collaborator from TISS, and by Prof. Ayona Datta (PI), in University College London (UCL). This is a five year (2022-2026) European Research Council (ERC) Advanced Grant - funded project, "Regional Futures: The territorial politics of digitalization-as-urbanisation in the global south".

The appointment will be from 1<sup>st</sup> January 2023, fulltime and is funded for three years. The term and conditions of appointed will be as per the TISS Project Staff Appointment Rule.

#### **Duties and responsibilities**

- Work in a highly collaborative manner with team members and maintain regular communication with PI and across the team.
- Identify and make contact with key informants and stakeholders in order to carry out the required programme of research.
- Develop in collaboration with team members, novel methods for studying the digitalizing state and information infrastructures.
- Conduct field research in order to collect relevant and high quality data and work collaboratively with other team members.

- Transcribe and translate documents, audio/video clips and field interviews from local language to English.
- Contribute to coding and analysis of data for the project in collaboration with other team members and using team approved software. This will include interviews, interpretation of observations and documentary analysis.
- Conduct research in an ethical manner and follow all ethical protocols of TISS, UCL and ERC.
- Record, transfer and safely store (according to Data Protection rules of all participating countries) interview material, transcripts, documents and personal information for the purposes of research.
- Be meticulous in data archiving to fulfill commitments of all participating countries to open access, and where necessary undertake training to fulfill these requirements.
- Be efficient in personal time-management and be meticulous in maintaining time-sheets to fulfill funder obligations.
- Maintain detailed and accurate records of all project documentation including team meetings and communications.
- Contribute to the project website through blogs, reports, working papers, op-eds, podcasts and other public facing outputs.
- Co-organise and lead at least 3 local stakeholder workshops in line with project objectives.
- Make an active contribution to individual and collaborative research outputs, publishing edited volumes, internationally leading journal papers and other academic and public outputs.
- To deliver outputs on time and to agreed specifications with project PI and other team members.
- Assist in and provide support to project team during field visits.
- Contribute to the dissemination of project findings in appropriate academic and stakeholder settings.
- Maintain own continuing professional development through the above activities.
