## About ROOTS-Rekkalu (Wings) Project:

The ROOTS-Rekkalu project aims at strengthening comprehensive rehabilitation for children in the institutions through psycho-social intervention and vocational education & skilling opportunities.

Focus areas of the project: Psychosocial support to children through individual, group and family conferencing; preparing/assisting in preparing case reports and ICP; and working with specific JJBs by the caseworkers and counsellors; skilling and vocational education through programmatic interventions, such as referrals for vocational courses, providing in-house skill training, entrepreneurship, on-job training and pre-vocational training facilities in partnership with different stakeholders. Overall the integrated project enhances the psycho-social wellbeing of care leavers, builds confidence and self-esteem and facilitates their abilities to gain employment in their area of interest, and enable their meaningful participation in society.

#### Job Profile: (Post 01) VT Manager

Duties and Responsibilities:

- Establishing contact and building partnerships with external organisations to implement the programme plan of creating VT opportunities for adolescents
- Setting up in-house VT programmes within the CCIs.

- Regular coordination with stakeholders involved in the implementation of VT programme, like, instructors, partner organizations, CCI administration, JWCS department etc.
- Maintaining complete data of adolescents enrolled in different programmes.
- Regular update of data to track the students' progress and further needs.
- Operationalisation of production unit attached with the in-house training unit.
- Setting up a system for marketing of products from the production unit.
- Setting up of Skill Lab for children between 12-15 years of age.
- Building partnerships with external organisations to facilitate internships and job placement

### Job Profile: (Post 02) Rehabilitation Coordinator/Skill Lab Facilitator/Bridge Course teacher

- Maintaining a database of eligible adolescents for the VT programme in all CCIs.
- Regularly updating the eligibility database
- Administering the VT assessment to eligible adolescents and preparing individual VT plan.
- Coordinating the process of enrolment, training, internship and job placement for adolescents.
- Ongoing progress tracking and mentoring for enrolled children, and counselling referrals, if needed.
- Regular Coordination with different stakeholders like Home administration, family, JJB/CWC, instructor/educational institution for child's rehabilitation-related needs.
- Preparing an aftercare plan for the student and coordination with DCPU or Probation Officer for aftercare follow-up with the child.
- Assisting the VT Manager in setting up of the programme and building partnerships.

## Job Profile: (Post 03)- Case Worker

- Being the primary contact person supporting the child to navigate through he procedures of the JJ system.
- Orientation to child and family about the case procedure at the time of admission in the CCI.
- Facilitating regular communication of the child with the family/guardian.
- Preparing Social Investigation Report (Form 6)
- Conducting home visits, and interaction with the child and the family to understand the vulnerabilities and identify rehabilitation needs.
- Providing assistance to the child and the family by connecting them with relevant resources and referral services for rehabilitation and social reintegration.
- Facilitating family conferencing process to build and strengthen familial care and support for the child.
- Attending case proceedings by JJB and presenting the case documentation and recommendations for rehabilitation to the Board.
- Maintaining the child's case file with all documents from entry to exit and the final order.
- Preparation and submission of ICP and pre-release report for each child to the JJB.
- Coordination with DCPU or concerned stakeholders for aftercare follow up with the children.

Project requires selected candidates to join immediately. Kindly apply accordingly.

These positions are on a contractual basis for the period mentioned above and are extendable further. Please note that these are full-time positions (5-6 days a week and at weekends). It is based in Hyderabad.
