#### NOTE :-

- i) If vacancies in Level-4/5 of particular sports discipline are not filled due to non-availability of suitable candidates, such vacancies will be filled in Level-2/3 from the same sports discipline where vacancies are notified.
- ii) Sportspersons having sports norms for higher Grade Pay (Level) can apply against the vacancies for the lower Grade Pay (Level). However, he will not claim for higher Grade Pay (Level) after joining the Railways on the basis of sports achievements prior to joining Railways.
- iii) There is no reservation for SC, ST and OBC, being a Sub-quota. However, the candidates claiming to belonging to SC/ST/OBC communities are required to upload **Self Attested photocopy** of Caste Certificate issued by Competent Authority. (As per Annexure- C & D)
- iv) The number of vacancies indicated in this notification is provisional and may decrease or even become NIL at a later stage depending upon the actual needs of the Railway Administration. The Railway Administration also reserves the right to cancel the notified vacancies at its discretion and such decision will be final and binding on all. In the event of cancellation of notified vacancies, the examination fee paid by the candidates will not be refunded.

#### 3. NATIONALITY / CITIZENSHIP

- (I) A candidate for appointment to Railway Services must be:
- (a) a citizen of India, or
- (b) a subject of Nepal, or
- (c) a subject of Bhutan, or
- (d) a Tibetan refugee who came over to India before 1st January, 1962, with the intention of permanently settling in India, or
- (e) a person of Indian origin who has migrated from Pakistan, Burma, Sri Lanka, the East African Countries of Kenya, Uganda and the United Republic of Tanzania or from Zambia, Malawi, Zaire, Ethiopia and Vietnam with the intention of permanently settling in India. Provided that a candidate belonging to categories (b), (c), (d) and (e) above shall be a

person in whose favour a certificate of eligibility has been issued by the Government of India.

(II) A candidate in whose case a final certificate of eligibility is not available he can be admitted to the examination but, if selected, the offer of appointment will be given only after his submission of necessary final Eligibility certificate issued to him/her by the Government of India.

#### 4. Eligibility Conditions

#### 4.1 Age limit

Minimum 18 years and maximum 25 years as on 01/01/2023. Candidates born between 02/01/1998 and 01/01/2005 (both days inclusive) should only apply. No age relaxation (Upper and Lower age) is permissible.

#### Note-

- (i) Persons if appointed to the category of Clerk-cum-Typist should acquire Typing proficiency of 30 w.p.m. in English or 25 w.p.m. in Hindi within a period of four years from the date of appointment; else his/ her appointment will be treated as provisional till such time that he/she passes the Typing Test.
- (ii) In case, the candidates are found suitable and are appointed in the Railways they have to undergo training for the period prescribed for the particular post in which they will be offered appointment, in case training is necessary for the particular post.

- (iv) Represented a state and obtained at least 3<sup>rd</sup> position in National games organized under aegis of Indian Olympic association **OR**
- (v) Represented a University and obtained at least 3<sup>rd</sup> position in All India Inter University Championships organized under the aegis of association of Indian universities **OR**
- (vi) Represented a State or equivalent Unit and obtained 1<sup>st</sup> position in Federation Cup Championships (Senior Category).

**Note** – For selection the priority will be as follows:

- (a) Preference will be given in the following orders :-
  - (i) International event recognized by respective sports federation,
  - (ii) National event recognized by respective sports federation,

  - (iv) University and so on.
- (b) In Athletics if there are similar achiever candidates priority will be in the following order-Sprinter, Middle distance runner, Throws and Jumps.

# 4.4 Additional acceptable sports achievement/Minimum sports norms for certain disciplines:-

- (i) In Athletics, Medal winning performance in National Inter State Senior Athletics Championships, may also be considered for recruitment against the post having Level-2 as per 7<sup>th</sup> CPC.
  - **In Athletics,** Gold Medal Winner in Open National Championships (Senior), Inter State Athletics Championships (Senior) and Asian Championships (Senior) may be considered for recruitment in Level-4/5.
- (ii) In Hockey (Men), for recruitment against the posts having Level-2/3 as per 7<sup>th</sup> CPC: participation in the International Tournaments (Senior or Junior) of four or more nations, may also be considered.

- All the championships mentioned above should be conducted under the aegis of recognized International/National/State sports and Federations and also recognized by the Railway Sports Promotion Board.
- A sportsperson will be considered for recruitment only for event/position/game advertised in which he has recognized sports norms. Sportsperson having sports achievement/eligibility norms for post carrying higher Level as per 7<sup>th</sup> CPC will also be eligible for post carrying lower Level as per 7<sup>th</sup> CPC. Separate applications for each category should be made along with requisite examination fees.
- Only those sportspersons who have acquired the sports achievement eligibility norms in the championships on or after 01/04/2020 and are active will be eligible to apply for appointment against sports quota. For validity of sports achievement, concluding day of the championship/event shall be taken into account.
- All the candidates getting appointment through Sports Quota will undergo probation period of two years.
- All certificates should have been issued on or before the date of issue of Notification.

#### 6. Document to be uploaded along with application form :-

Candidates may note that RRC/WCR may, at any stage, reject the applications for uploading old/unclear photograph or for any significant variations between photograph uploaded in the Application Form and the actual physical appearance of the candidate. Candidates are advised to keep two additional copies of the same photograph ready with them for bringing at the time of Document Verification, later.

#### b. Signature.

- g. Self attested copy of Fee exemption certificate i.e. SC/ST/EBC/Minorities certificate etc.

#### 7. Examination fee:-

- a. The examination fee is ₹500/- (Rupees Five Hundred only) for all candidates except those mentioned in sub-para (b) below with a provision for refunding ₹400/- to those who are found eligible as per the notification and who actually appear in the trial after deducting the bank charges.
- b. The examination fee is ₹250/- (Rupees Two Hundred Fifty only) for candidates belonging to SC/ST/Ex-servicemen/Women/Minorities and Economic Backward Classes with a provision for refunding the same to those who are found eligible as per the notification and who actually appear in the trial after deducting the bank charges.
- c. While applying, the candidates claiming fee exemption must submit necessary certificates i.e. SC/ST/EBC/Minorities, in the format as prescribed (i.e Annexure-'C', 'B', 'A') in the Central Government order.
- d. Fee should be paid ON-LINE using internet banking or debit/credit cards (service charges apply for all banks which will be borne by the candidates).
- e. On successful completion of the transaction, e-receipt with the date entered by the candidate will be generated which should be saved / printed and retained by the candidate.
- f. If the online transaction is not successfully completed, please make payment online again.

- g. Applications not accompanied with examination fee, wherever required, will be summarily rejected.
- h. Economically backward candidate means those candidates whose annual family income is less than ₹50000/-. They have to upload income certificate as given in Annexure-B.
- i. Minorities mean Muslim / Sikh / Christian / Buddhist / Jain / Zoroastrians (Parsis).
- j. Candidates should provide the correct details of beneficiary Bank Account in which they would like to receive the refund viz. beneficiary name, Bank name, Account number and IFSC Code while filling up the application form to facilitate refund of fees to the eligible candidates as per Para 7, a & b above after deducting bank charges. Fee in respect of candidates who are found ineligible shall not be refunded. Fee in respect of candidates who are ineligible, but still apply, shall not be refunded.
- **8. Invalid Applications/Rejections:-** Candidates are requested to read all instructions thoroughly before submitting ONLINE application, otherwise their applications are likely to be rejected on one or more of the following reasons.
- (i) Applicants who are not fulfilling norms for recruitment as per para 4 of this notification.
- (ii) Over age or under age.
- (iii) Certificates not uploaded/uploaded certificate are not readable.
- (iv) Any other irregularities which are considered invalid by RRC.

The candidature of candidate may also be rejected if (i) the candidate submits multiple applications for the same post and category; (ii) the candidate submits multiple applications with different community for the same post & category; (iii) the candidate submits multiple applications with different photo (face) for same post & category and (iv) the candidate submits multiple applications with different documents for the same post & category

In case the application is rejected, candidates will be able to view their status ONLINE on the website of West Central Railway along with the reasons for rejection(s). SMS and email alerts shall also be sent to the candidates on their registered mobile numbers and e-mail IDs, if indicated in their ONLINE application. Candidates will not be intimated by post regarding the reason(s) of rejection.

#### 9. Selection Procedure:-

9.1 Eligibility of the candidates for the post notified in this notification will be scrutinized by scrutiny committee on the basis of the information furnished by them in the ONLINE application based on the eligibility conditions mentioned in Para 4 and Para 8 of this notification. All eligible candidates will be called for Trial and after Trial only the FIT candidates shall be assessed for next stage of recruitment. Candidates declared NOT FIT by the Trial committee will not be assessed further by the recruitment committee.

#### 9.2 DISTRIBUTION OF MARKS:

9.2.1 Trials of the candidates shall be conducted to assess their sports performance and suitability. Trial Committee shall give its recommendation in terms of either FIT or NOT FIT, for consideration for next stage, by giving marks (maximum 40 marks), as per the criteria given below:

#### **Explanatory Note:**

- i) Candidates who are found FIT in the Trial only will be considered for the next stage of recruitment.
- ii) The recruitment shall be purely on the basis of merit. In case of more than one sportsperson score the same marks, preference will be given to younger candidate to decide the merit.
- iii) The Sportspersons, who will be useful for the Railways, i.e. if they fit in the WCRSA team, will only be considered.
- 9.2.3 Recruitment Committee shall award the marks (out of 60 marks) only to the FIT candidates for their sports achievements, educational qualifications. Candidates declared 'NOT FIT' will not be assessed further by the Recruitment Committee.
  Recruitment Committee is to add the marks given by the Trial Committee to the FIT candidates (i.e., out of 40 Marks), in order to make the final merit list (out of 100 Marks).

#### 10. Important Instructions:-

10.1 Candidates to ensure their eligibility before applying:- The candidates should ensure that they fulfill all eligibility conditions prescribed for the post/examination. Eligibility of the candidates for the post notified in this notification would be decided on the basis of the information furnished by them in the ONLINE application. If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his application is false/incorrect or the candidate has suppressed any relevant information or the candidate otherwise does not satisfy the eligibility criteria for the post(s), his candidature will be cancelled forthwith.

- Qualification and Sports Achievement etc on the day of Trial is mandatory without which they will not be allowed to appear in the Trial. Certificates in languages other than English or Hindi should be submitted by an attested translation in English/Hindi. Photocopy of all documents should be self attested. No TA/DA/Accommodation will be given for appearing in the selection trials. Applicants will have to bring their own kit and also four-passport size photographs. They may also be required to stay during the selection for 2-3 days, for which they have to make their own arrangements. The railway administration has all rights reserved to fix any date/place or postpone trials or cancel due to unforeseen causes against which no claim will be accepted.
- **10.3** Candidates should be in readiness to appear for the trials etc at short notice after the last date for submission of application is over. Selected candidates will be posted anywhere on West Central Railway.
- **10.4** Candidates will have to pass suitable Medical Examination applicable to the post allotted to them.
- **10.5** Candidate applying for more than one game/event shall submit separate applications with separate fee.
- **10.6** Candidate those who are already in service of PSU/Government Organisation and are eligible for the above, should submit "No Objection Certificate" for the same from their employer.
- 10.7 Candidate's admission at all stages of the recruitment will be purely provisional subject to satisfying the prescribed eligibility conditions. Mere issue of call letters to the candidate will not imply that his candidature has been finally cleared.
- **10.8** Selected candidates will have to submit "Service Bond" of 5 years at the time of appointment.
- **10.9** Sportsperson recruited against sports quota shall be terminated from service, if the information and documents furnished by him for recruitment, are found incorrect/fake at any stage; observing requisite procedure for such termination.
- **10.10** The candidates would be selected for employment only if they fit in the West Central Railway Sports Association team.
- **10.11** The decision of selection committee in all matters relating to eligibility, acceptance or rejection of application etc. will be final and binding on the candidates and no inquiry or correspondence will be entertained in this connection.
- **10.12** During submission of ONLINE application, a registration number will be issued to each applicant. Candidates are advised to preserve/note their Registration Number for further stages of recruitment process/correspondence with RRC.
- 10.13 Candidate need not send any application printout or certificates or copies to RRC WCR by post. The candidature of the candidate will be considered only on the strength of the information furnished in the ONLINE application, which is subject to verification at a later date. Any deviation, whatsoever, found in the particular field in the online application with the document produced will result in disqualification of the candidates at any stage.
- **10.14** Candidates are advised to take printout of their application which is required to be produced at the time of Selection Trial.
- **10.15** Canvassing in any form shall disqualify the candidature.

- **10.16** The selection of the candidate by the Railway Administration does not confer any prescriptive right on the candidate for the post.
- **10.17** The Railway Administration is not responsible for any postal delay or wrong delivery.
- **10.18** The Railway administration reserves rights to rectify inadvertent error or omission at any stage of recruitment and an erroneously appointed candidate shall be liable to be summarily removed from Railway Service.
- **10.19** In case of any dispute, English version of the Employment Notification will be treated valid.
- 10.20 The ONLINE application process is a serious matter for recruitment in public service. The applicants are expected to take it in all seriousness. Any attempt by the applicants to manipulate the process by furnishing false information or mischief by uploading obscene/objectionable photograph or matter shall be dealt severely and they shall be liable for criminal action, besides other administrative action.
- 10.21 Candidates selected through Sports Quota will have to perform in his field of sports for a minimum period of 5 years. His performance will be assessed during first two years of service (Probation period). In case performance is not found up to the mark, his service is liable to be terminated.

#### 11. Suppression of facts/warning:-

Any material suppression of facts or submitting of forged certificates/caste certificate by a candidate for securing eligibility and/or obtaining privileges. Including free travel for appearing in the examination shall lead to rejection of his/her candidature for the particular recruitment for which he/she has applied. Further, he/she will also be debarred from all examinations conducted by all RRB/RRC over the country for a period of 02 years and legal action may be initiated, if warranted,
